## Customer Water Service Line **Installation Agreement** **Within MBMA Water Main & Service Line** Upgrade/Extension Areas

### GENERAL CONDITIONS

Authority acknowledges that all work shall comply with the MBMA ("Authority") Rules and Regulations and authorized approvals at duly advertised meetings related requirements of the Water Meter Pit and the installation.

Authority's work will be completed by its operating agent, West Branch Regional Authority ("WBRA").

Authority shall warrant the materials and workmanship for the work completed for a term of 1 year from the date of completion.

Authority's charge for the water line (or additional water lines if applicable) installation will be discounted since work on Authority-owned portions of the system is occurring nearby.

Property Owner will pay purchase costs for the pipe, fittings, backfill (or additional service lines if applicable) and any hardscaping (i.e., concrete, pavement etc.)

Project may involve unforeseen circumstances, including but not limited to exposure of deteriorated and/or poorly located water supply lines, that may increase parts and materials cost to Property Owner not described in this contract.

Any atypical costs involved in installing the service line on the property (includes additions, porches, patios, walls, decks, garages etc.) will be the responsibility of the Property Owner.

Rerouting indoor plumbing (building water) may be necessary to avoid extensive outdoor excavation or other extenuating circumstances involving existing property features and will be the responsibility of the Property Owner to complete prior to the Authority completing the water line installation.

Trees, shrubs, and plants may be removed or damaged during construction and will not be protected or replaced.

Owner agrees to remove landscaping, fences, or other obstacles to facilitate installation of the water line.

Authority, at the Authority's expense, will restore portions of the Owner's property disturbed during construction to a condition substantially similar to its condition prior to construction, with the exception of trees, landscaping, plants, walls, fences or other obstacles for installation of the water line.

Authority's obligations will consist of seeding the restored surface after installation of the water line.

The Authority will place topsoil and grass seed to restore lawn areas disturbed by construction of the water line. Owner is responsible to maintain seeded areas and water as needed to keep grass viable.

Soil may settle over time; the Authority will return to Owner's property to address significant soil settlement up to two times within one year of the water line installation.

After installation, the Property Owner will own the water meter pit in addition to the water line running from the pit to the structure receiving the water utility.

Property Owner will be responsible for maintenance of their water line between the structure and the water meter pit near the property right-of-way. Accordingly, the Authority assumes no responsibility or maintenance associated with Property Owner's water line from the structure to the water meter pit.

The Owner agrees to indemnify the Authority and WBRA for any claim made by a successor in interest should I transfer the property to another prior to the completion of construction and installation of the water line. Additionally, I hereby release and discharge MBMA and WBRA for any claims, damages, or demands that I may have under the Eminent Domain Code, 26 Pa.C.S. § 101 et seq., for or on account of this grant of authority and also for any injury to or destruction of the aforesaid property through or by reason of the aforesaid construction or improvement.

I. PROPOSAL

For the consideration named herein, the Authority agrees to furnish all materials/equipment and to perform all the work described in, and in accordance with this Contract, for the price of

II. WORK DESCRIPTION

**The proposal is to include all the work identified below in accordance with WBRA detail specifications:**  
Furnish and install the water meter pit within the property boundary as close to the right-of-way as practical where current curb stop is located unless determined otherwise, including excavation, bedding, backfill, compaction, fittings, site clearing, traffic control, protection of existing facilities (includes using the appropriate amount of backfill and compaction around exposed utilities), cleaning, testing, connection to the water main, restoration to previous conditions including sidewalk concrete and curb if needed.
